The Annual Budget General Meeting (ABGM) of the North Western Reform Synagogue will be held on Tuesday 12 December 2017 in the Leo Baeck Hall at Alyth Synagogue.

This year, in order to make greater use of electronic communication, notice of the ABGM is being sent out electronically. The Agenda for the meeting will be as follows:

1. To confirm the recommendation from Council, that the Synagogue annual subscription for 2017 (net of basic rate tax) be increased by between £14 and £18 depending upon the tax status of the Member, this being equivalent to an increase of 3% which is in line with the current rate of Retail Price Inflation at September 2017.
