Note I.

Trustees' Report and Financial Statement:

The Trustees' Reports and Financial Statements reflect the operation of the incorporated charity NWRS (Company No. 12336110 and Charity No. 1186738) for the period September 2022 - August 2023. These accounts reflect how the Synagogue operates on a day-to-day basis. As in previous years we will be reporting under the headings. *Pray with us, Learn with us, Live with us, Be with us,* reflect the way in which our Rabbinic and Professional Team work across a number of areas of synagogue life at any one time, ensuring that delivery of services and programmes, member support and engagement and the day-to-day operation of the synagogue function in a holistic and collaborative way.

The Trustees' Report and Financial Statement have been approved by the Trustees and are being recommended to the Members for approval at the Annual Meeting of Congregants on 5 February 2024.

Note II.

Election of new Trustees to the Trustee Board:

In accordance with the Rules, the Interim Nominations Group have reviewed and interviewed interested candidates who have indicated their willingness to put their names forward for election for a three-year term to the Trustee Board at the Annual Meeting of Congregants in February 2024.

In accordance with the Article 14.4 and Rule 8, **Juliet Levinson, Ben Portner and Noemi Zell** have agreed to put their names forward for election to the Trustee Board. The Interim Nominations Group recommended to the Trustee Board that Juliet, Ben and Noemi's name be put forward for election by the Membership.

The recommendation was unanimously confirmed by the Trustees.

Note III.

Election of a President and Vice President:

The roles of President and Vice President are an established and integral part of Alyth and our leadership. We are blessed to have outstanding members who have served as previous Presidents and Vice Presidents and remain grateful to them for their service and unstinting support.

The term of office of the President is two years, with the option to stand for re-election for one further term of two years in consultation with the Trustee Board. Vice Presidents are elected on a three-year rolling basis, with one person retiring each year at the end of a three-year term.

Jon Epstein (President) and Robert Weiner (Vice President) come to the end of their terms at the Annual Meeting of Congregants in February 2024. The Trustees, Clergy, Professional Team and the Community are enormously grateful to Jon and Robert who have brought experience, wisdom and care for the community to the role.

In accordance with Article 21 and Rules 4 & 4.3, **Andrew Gellert** has agreed that his name be put forward for election as President of Alyth. The Interim Nominations Group recommended to the Trustee Board that Andrew's name be put forward for election by the Members as President. The recommendation was unanimously confirmed by the Trustees.

In accordance with Article 21 and Rules 4 & 4.4, **Ruth Wellin** has agreed that her name be put forward for election as a Vice President of Alyth. The Interim Nominations Group recommended to the Trustee Board that Ruth's name be put forward for election as a Vice President. The recommendation was unanimously confirmed by the Trustees.
